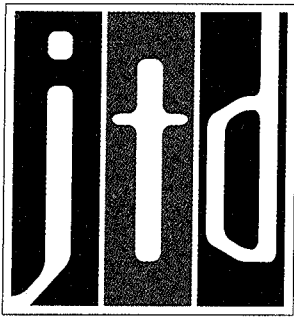

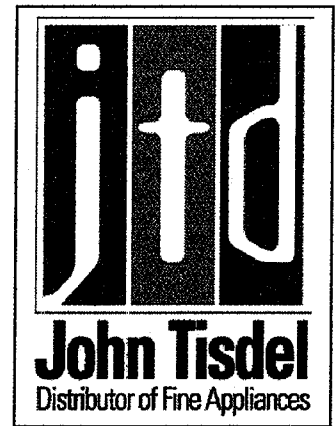
- Consumer's dealer invoice must be dated between 7/1/09 and 12/31/09.
